



#### **Financial Notes**

- ✓ Financial reports, including restricted loan funds, are provided quarterly to the full board or as otherwise needed
- ✓ Fiscal year financials @ June 30, 2023, are presented at the September meeting
- ✓ Budget amendments, if necessary, are brought before the full board.
- ✓ Adjustment to the budget presented to the Executive Committee on July 25, not presenting a negative impact, are noted below
  - 1) Total wages went up slightly over budgeted amount + \$2,500 (expense)
  - 2) Employee benefits cost went down significantly \$10,144 (expense)
  - 3) Directors & officers liability insurance was reduced as SOREDI now has a policy & procedure manual in place \$2,500 (expense)
  - 4) Storage lease was eliminated \$770 (expense)
  - 5) Loan program administrative transfer was incorrect, +25,251 (revenue)
  - 6) Changes resulted in net gain of \$36,165 to budget approved at May 2023 board meeting.





# Recruitment Projects, Confidentiality

- **Project Murphy** (Oct. 2022) Distribution & Fulfillment Center in **Central Point** Neary 90,000 s/f of facility planned. 100-200 jobs expected. Total investment unknown. Expected to be operational, December 2024
- Project Adventure Food manufacturing in Ashland. Has signed a lease for the former Maranatha Nut Butter facility. 15-20 jobs over time. \$1.2 million investment. Enterprise Zone Applicant, expected to be in operation, January 2024
- **Project Green** (May 2021) Bio technical science industry, building new facility in **White City.** Expected groundbreaking September 21. \$14 million investment, 22 jobs, 35,000-/sf to start. Expected to be future HQ, as well.
- Project Bundle Wood products company, local expansion to Phoenix. Formerly located in Central Point Pacific Wall Systems. Leasing property formerly occupied by Boise, effective July 1. Expected enterprise zone application for additional facility on site.

# **Regional Innovation Hub Plan**

- \$120,000 grant from Business Oregon to SOREDI to serve as the fiscal manager of Southern Oregon Regional Hub project.
- 14-member Hub Group approved Regional Innovation Hub plan August 7.
- Plan will be publicly presented in next phase
- Steering Committee now being formed to carry plan forward into implementation and assist with MOUs, and investments needed to implement, and determine best regional agency to house the continued effort.
- Consultant, Civic\* Possible still engaged and will assist with next stage in applying for grant from Business Oregon to implement, through November 2023.
- Vision: "The Rogue Valley Innovation Hub connects entrepreneurs from different areas to collaborate, exchange ideas, and build a brighter future together."
- Primary Goals:
  - 1) Build a hub by establishing a team platform
  - 2) Support Collaborative programming
  - 3) Harness collective resources
  - 4) Recognize and build upon success
