Rogue Valley Council of Governments (RVCOG) – Ann Marie Alfrey

- Introduction of Vicki Robinson, SOREDI's bookkeeper
- **RVCOG** services:
 - Designated Area Agency on Aging for Jackson and Josephine Counties (AAA)
 - o Home to Rogue Valley Metropolitan Planning Organization (RVPO) and Middle Rogue Metropolitan Planning Organization (MRMPO)
 - Collaborate with members to obtain funding or provide services
 - o Contract directly with members for specific services such as grant administration, land us planning, IT, human resources, financial, and administrative services
- Recent acquisition of the former Pathways building from the City of Central Point
 - Much needed kitchen and storage space for their senior programs
 - An additional \$1M is needed to upgrade the current kitchen for use by Senior Services

SOREDI Project Updates

Housing Projects & Recruitment - Terrill Roper, Business Development Manager

- Project Save, a manufacturing facility and headquarters, is looking at properties in White City and the Croman property in Ashland
- Working with Annum to identify workforce housing gaps in Southern Oregon by using a survey to employers
- The survey project has begun to identify businesses to participate in the survey, which is at no cost to the business

Loan Program Updates - Ryan DeRoo, Business Loan Manager

- The Loan Committee has approved a local chiropractic/sports therapist clinic as a gap loan, partnering with bank
- The Loan Committee approved a loan modification for a client with 6 months of interest-only payments
- Currently at 20 out 29 delinquent loans, an improvement from 9 out of 30 last year at this time.
- Enterprise Zone two new applications and conversations about EZ boundary expansion for PH5 &
 PH3

PIER & SOIH Grant, - Amy Browne, Operations Manager HB3395 —

- This is a collaboration with RVCOG
- Current projects include the Gold Hill Code Audit and the Jacksonville Planning Commission
- In partnership with RVCOG, running 2 micro grant programs. 1) Phase 1 Environmental Site Assessments 2) Accessible Housing Development

PIER – Phoenix/Talent Revitalization Project

- A 3-year grant and program for \$500,000 for which SOREDI is the fiscal manager
- Joint project with the City of Phoenix and Talent Business Alliance (TBA) recovery funds from OHCS
- Program Activities Microenterprise training and technical assistance, training coordinator capacity, Business incubator

SOIH -

- SOREDI received the Business Oregon \$400,000 grant to support SOIH for two years
- Kim Freeze is ¾ time and Abigail Skelton is ½ time support
- Full scope of work will be shared at the October board meeting

Nexus Project & Technical Assistance Grant – Kim Freeze, Innovation Ecosystem Director Nexus Project –

• For the purpose of creating more centers/hubs within communities to connect. This project would include an incubator space, office space for SOIH and SOREDI, and kitchen.

Technical Assistance Grant –

- SOREDI goal was to raise \$1.2M in grants this year and we have already reached it
- The TA grant is for \$300,000 to underserved population programs
- Talent Business Alliance (TBA) has also sent in a complementary app for this grant and is a mutual partner, submitting letters of support for each other
- TBA will focus on Latina entrepreneurs
- SOREDI and hub along with community support partners will provide technical assistance focused on AI, technology, science, and traded sectors
- WESO will offer business training and mentorship for female entrepreneurs
- This grant is a traded-sector science/technology focus
 - This grant will help continue trainings such as the recent free patent workshop A local patent consultant gave advice resulting in two new patents

Sundell shared his vision for SOREDI, followed by questions/comments by directors.

Roundtable Updates

Marta Tarantsey -

- The \$800,000+ Municipal Wildfire Assistance Grant award to Jackson County has been closed out recently, showing the long-lasting impact and organizations that work in the communities recovering from the 2020 Fires
- Business Oregon awarded two childcare grants in funding Round 2: Family Nurture Center at \$90,000 and \$700,000 for a new childcare center in Grants Pass, which includes new property acquisition
- There has been significant progress in the fiber optic install in Shady Cove, funded through the Oregon Broadband Office in partnership with Hunter
- There are housing infrastructure technical assistance grants available up to \$100,000 for municipalities and \$250,000 for providers
- RWP and SOWIB on the Southern Coast applied in partnership for the Governor's Statewide
 Activities Grant and were awarded \$750,000 to support housing construction workforce with a
 focus on expansion of the pre-apprenticeship program and creating access to registered
 apprenticeships. SOWIB is building their program based on our region's model.
