 - SOREDI has segregation of duties (Reviews by multiple parties)

- SOREDI requires authorization of payment (Invoices, W9s needed)
- SOREDI implements physical controls (Payments completed in a timely manner)
- SOREDI follows record keeping procedures (Statements, deposits, etc. stored and shared)
- SOREDI has audits (Annually)
- SOREDI follows loan documentation procedures (Quarterly reports balanced)
- SOREDI regularly discusses banking and other items (Changes require processes)

 - Executive Director Request to Board: Increase the Professional Services expense category in the amount of \$5,000 to support loan recovery efforts and legal document review.

2. Increase in Computer Software (Line 5106) and Small Tools & Equipment (Line 5108, Supplies & Materials Category)
 - Executive Director Request to Board: Increase the Total Supplies & Materials expense category by \$16,885 to pay for the SizeUp platform and equipment for the Business Development Manager for Josephine County.
 - Aaron Cubic Moved to Approve. John Vial and Terry Hopkins Seconded. All approved. Motion carried.

Items for Discussion

1. Search for New Facility & EAA Grant Opportunity
 - Sundell explained that the U.S. Economic Development Administration (EDA) has communicated with SOREDI regarding the Economic Adjustment Assistance (EAA) grant. The EAA grant is a federal program designed to help communities and organizations respond to economic challenges and opportunities by supporting infrastructure and facility projects that drive regional economic growth.
 - The EAA grant can finance up to 80% of the cost of a new SOREDI facility, making it a critical funding source for the goal of purchasing and developing SOREDI's own building.

Current EAA Grant Status:

- While applications are accepted on a rolling basis, current funding is unavailable, and new applications are likely to be backlogged until mid-2027.

- SOREDI will reconvene the Facilities Committee to begin looking at potential buildings and funding for relocation.

Board of Directors Roundtable

- **Rick Bailey** – SOU generates \$282 million per year. To keep that going, the university has created QR codes for businesses that take students to the application website directly. These unique QRs have organization-specific promo codes that waive students' application fees.
- **Marta Tarantsey** – Shared that the Governor's office has launched the [Governor's Prosperity Roadmap](#) – released late December. Business Oregon has also released the [DRAFT Economic Development Strategy Framework](#). The framework is organized into 8 distinct action areas that reflect the most pressing challenges and opportunities. On a personal note, Business Oregon has given Tarantsey Klamath and Lake counties, in addition to Jackson and Josephine.
- **John Vial** – Rogue X turned two years old. Working on economic impact report. Next month, items will go to council about furthering Creekside Quarter expansion.
- **TJ Holmes** – Reminded the group of Rogue X's cornhole tournament in two weeks. Creekside quarter vote went through.
- **Terrill Roper** – Thanked Daniel Marple for a great industry tour at Herb Pharm.
