Call to Order and Opening Comments - Chris DuBose, Board President

Meeting brought to order 3:08. Quorum met.

Executive Committee Update from May 27, 2025 – Kaycee Miller, Board Vice President

1. Board Changes

- a. Tom Fisher's to resign from the board as of May 31, 2025
- b. EC will announce during the June Board meeting

2. SOREDI Executive Director Position

- a. Job posting is live on a variety of websites
- b. Enlisted the help of a firm to widen the candidate pool and is working with WBCP Wendi Brown.
- c. Meeting with the search committee scheduled for the beginning of June and an update to the board will be given during the June Board meeting.

3. The One Rogue Valley Reimagined 2025-2030 CEDS

- a. The Executive Committee approved the CEDS draft.
 - i. **EC recommends:** Send to the Board for full approval during the June Board meeting.

4. Revolving Loan Fund 2025-2030 Plan

- a. The loan committee is currently reviewing the draft RLF Plan. If approved, they will recommend for Board approval June 10.
- b. Chris will send out the draft plan to the EC. Amy made note that draft CEDS initiatives are included in this RLF draft and will be replaced with final edits once approved.

c. EC recommends: Send to the Board for full approval during the June Board meeting.

5. Southern Oregon Innovation Hub Grant

- a. The grant application is due and will be submitted today.
 - i. The funding will be for the next two years, either \$500K or \$430K
 - ii. Tech, mentorship and incubator spaces is the new grant focus, leaving SOREDI to take on some of what SOIH had been doing such as pitch nights.
- b. Once approved by the Oregon Innovation Council, SOREDI can be reimbursed from the date of announcement of funding, which will potentially have a 30-60 day funding gap for Kim's position.
- c. June 30 will be the end of the SOIH General Council, ending the need for an SOIH SOREDI Board representative.

6. PIER Grant

- a. Awarded \$500,016 for the next three years
- b. The work of this grant is a partnership with Talent Business Alliance and the Phoenix Chamber
- c. Admin for SOREDI will be 15% total for the three years
 - i. A heavy lift for SOREDI due to CDBG reporting
- d. A press release will be announced once contracts are signed.

7. Closed session - Budget Discussion

a. EC recommends: Send proposed budget to the Board for discussion and approval during the June Board meeting.

Guest Introduction – Chris Dubose

Wes Cochran, EDA Economic Development Representative for Oregon & Washington

- 1. Cochran provides final approval for the One Rogue Valley Reimagined CEDS
- 2. Before his approval and the CEDS going public, the following requirements are still to be met:
 - a. A robust evaluation framework
 - b. Incorporate the concept of economic resilience
 - c. A separate call out/section for workforce development
- 3. He will then do a final review for approval prior to public review.
- 4. Cochran recommends the Board approve the draft document as is, subject to edits as noted above.

Consent Agenda – Minutes Approval – Kaycee Miller

March 11, 2025, minutes. Dr. Randy Weber made a motion to approve. Daniel Marple seconded. All approved. Motion carried.

April 8, 2025, minutes. Paul Anderson made a motion to approve. TJ Holmes seconded. All approved. Motion carried.

ED Search Committee Update – Chris DuBose

- 1. A recruitment firm, WBCP, has been contracted to broaden the candidate pool.
- 2. WBCP is only recruiting and not scoring. RVCOG and the search committee will start scoring in June, with July 9 and 18 set for interviews.

SOREDI Discussion & Approval (ACTION) - EDA CEDS - Chris DuBose & Amy Browne

- 1. Taneea Browning motioned to approve the 2025-2030 One Rogue Valley Reimagined CEDS as is, subject to additions requested by Wes Cochran:
 - a. Performance/Implementation Metrics Evaluation Framework
 - b. Incorporate the concept of economic resilience
 - c. Add a separate call out/section for workforce development
- 2. Marple seconded the motion. All approved. Motion carried.
- 3. The board will receive the final draft copy sent to the EDA. A vote by the Board will not be required.

SOREDI Discussion & Approval (ACTION) - EDA RLF - Chris DuBose & Ryan DeRoo

- 1. Ryan DeRoo noted that minimal change was made to the new Revolving Loan Fund Plan, which now reflects the requirements for the two remaining federalized loan funds. Any new EDA guidelines were incorporated into the document for the COVID-19 EDA Relief funds for loan fund #330.
- 2. Jessica Ayres made a motion to accept the 2025-2030 Revolving Loan Fund plan. Anderson seconded the motion. All approved. Motion carried.

SOREDI Discussion & Approval (ACTION) – CEDS – Chris DuBose & Amy Browne

- 1. Dr. Randy Weber made a motion to approve the 2025-2026 SOREDI Budget with the revision to include an additional line item to show that the \$80,000 3-year strategy plan funds are separate from any additional funds needed from Fund 300 to balance the budget.
- 2. Ron Doan seconded the motion. All approved. Motion carried.

SOIH Update – Kim Freeze

20 days are left in the Business Oregon Southern Oregon Innovation Hub Grant. The report for this first year and the application for the next round of funding have both been submitted. There is strong optimism that it will be approved. Because of the ten months of collaboration and strategic alignment over this last year, Freeze is confident about additional funding revenues and grants.

The <u>Global Entrepreneurship Congress</u> was in Indianapolis this year, only the second time in the US since its inception in 2009. Freeze personally connected with <u>Mark Cuban</u> and <u>Brad Field</u>, along with many international entrepreneurs. She also shared on a panel about rural ecosystem building. Field has offered to come to Oregon, free of charge, for a presentation and to see what's happening here in our entrepreneur ecosystem. We are atypical of other hubs in the state in the level of growth and support to our entrepreneurs in this first year.

Roundtable

Marta Tarantsey, Business Oregon – Two Business Oregon recruitment officers are going to be here the end of June to see the Croman site in Ashland and look at White City industrial properties. This will be a collaborative effort to look at actionable steps, not just a meet and greet. They may also do a mock site-visit in Josephine County.

Dr. Randy Weber – Rogue Community College is the recipient of Carnegie Foundation's designation of Opportunity College, the only one in our state.

Commissioner Rick Dyer – The multi-use pandemic response center at the Expo is a 120,000 s/f facility being built with ARPA (American Rescue Funds Act) funds and county general funds. This project is in cooperation with the city of Central Point, the Expo and Jackson County. It will be a combined community use, conference center, emergency shelter, and sports facility. Revenues generated will pay back any city/county funds used.
