Call to Order – Tom Fischer, President

President Fischer called the meeting to order at 3:08

<u>Providence</u> – Matt Newell, Providence Business Development

The Providence slide deck is available here.

- Newell has a ten-year history with Providence starting on the clinical side and has moved to the business side. Providence contributes to economic development by providing quality of health to Southern Oregon's workforce.
- Southern Oregon has a large Medicare/Medicaid population and is the 5th largest non-profit health system in the country.
- Partnering with RCC and SOU contributes to 80% of the graduates staying local.
- There are career ladder opportunities within Providence where employees can receive training for certification programs and are fully funded by Providence, utilizing partnerships across the country.
 Providence Medford has a strong local focus with local leadership.

PH3 and PH5 South Valley Employment Center – Zach Moodey & Eric Swanson

The City of Phoenix slide deck is available here.

Zach Moodey -

- Phoenix has expanded its urban growth boundaries to develop PH3 and PH5 along I5 and North Phoenix Road.
- The city is currently processing zoning codes. Developers will be providing the master plan.
- North Phoenix Reservoir Grants were received to develop
- Seeking grants for infrastructure to work south of PH5
- Road networks are currently being built to get the area ready for economic development Industrial, commercial and residential.

Eric Swanson -

- Phoenix is the fastest growing city in Southern Oregon and #5 in state.
- This parcel is the largest development land along the I5 corridor.
- Though they lost 25% of the city due to the fires and are still recovering, they are moving forward.
 - \$35M+ in grants federal, state and private.
 - Adding 160 affordable housing units and almost as much in marginal housing.

Questions/Comments

- It was noted this could be an ideal bio-tech property being halfway between Silicon Valley and Portland.
- The property has been recently zoned, so they are currently identifying the supporting uses. A key factor is walkability for these commercial/residential communities to minimize traffic.
- Challenges with the transportation plan have delayed development but they are actively working on an amendment to get it started.
- Though the developers have not yet identified how the space will be used, it could be designated for educational facilities. Code does not prohibit this type of use.

HB3666 – Wildfire Safety and Accountability Act

Supporting documentation for HB 3666 is available here

- The question being discussed is if SOREDI should officially provide support for Bill 3666
- It is a bipartisan bill supported by Representative Marsh.
- The bill will standardize wildfire mitigation statewide, resulting in a certification that protects electric utilities from liability.
- There is support from OEDA (Oregon Economic Development Association) KCEDA (Klamath County Economic Development) and EDCO (Economic Development for Central Oregon) along with support from various Oregon cities.

Questions/Comments -

- Meyer did not observe any pushback from those in attendance when the bill was presented, including no testimony from the insurance industry.
- It was asked: What are other states doing? Each state is unique in their efforts to mitigate these costs.
 California has adopted similar legislation. Other states are putting on liability caps or creating funds for liability costs.
- The cost hasn't been standardized yet. For example, 1,200 miles in JoCo are receiving updated poles at \$1M per mile, which will impact the rates, but it will resolve reliability issues.
- This wildfire state standard will show utility compliance to help control insurance rates and design quality of materials used.
- There is an existing WMP (Wildfire Mitigation Plan) here, but this will standardize for everyone around the state.
- Ron Doan made a motion for SOREDI to support HB3666. Tom Fischer seconded.

Discussion

- The clarified ask by Pacific Power is to use SOREDI's logo on materials for discussion in the House.
- Dr. Casey Schilling gave more details on the House Bill process amending the motion to use the SOREDI logo on printed materials that support continued discussion on HB3666 in the House.
- Tom Fischer seconded the amended motion

• All in Favor: 8. All opposed: 5. One abstention. Quorum reached. Approved. Motion carried. SOREDI logo will be provided to Meyer for use on discussion materials.

2. SOREDI Executive Director Position

Job posting is getting reviewed by RVCOG.

EC recommends: Let's aim to publish the job posting asap after review from RVCOG ED Job Search Committee confirmed members include:

Aaron Ausland (Private), Shela Clough (Private), Aaron Cubic (Public), Chris DuBose (President), Rob Field (Public), Steve Vincent (Public), Heather Stafford (Community Partner), Adrian Modjeski (HR- RVCOG).

3. March Board Meeting planning

Continue providing a virtual option at locations that support it Include updates on board member changes on the March agenda

4. Agency Updates

Financial: Staff are preparing the proposed budget for 2025-2026 for board meeting approval at the May board meeting

EC recommends: Provide quarterly financial updates during April's board meeting, with a draft ready in April to accommodate edits for final approval during the May board meeting. SOIH: Grant Project (phase 2) ends June 30th, 2025. When the new funding cycle (phase 3) is open we will apply again. This will be the same funding amount to be spent over 2 years, if approved. This program is highly successful and SOREDI would like to continue. Details are still coming in and Amy & Kim will keep us posted.

3. RLF Funds: There is one remaining loan fund (Fund 330) at People's Bank that can be moved to Umpqua, putting all our RLF loan funds at one location. Moving these funds would be a time-saver for SOREDI staff.

EC recommends: Move loan funds from People's Bank to Umpqua Bank and close the People's bank account.

- 4. Enterprise Zone: To get the EZ Manager name changed, a resolution will be presented to the City of Medford at their March 12 working session, along with going through the membership contract. Tom, Ryan and Amy will attend and make the presentation. They met with the county assessor and recently met with Jackson County on March 6 to go over the resolution.
- 5. HB3049: SOREDI provided written testimony showing support to industrial businesses
- 6. Jackson County International, Medford Airport: SOREDI wrote a support letter for the terminal expansion project.

Board Leadership Changes – Tom Fischer & Chris DuBose

Tom Fischer is presented with an award by Chris DuBose thanking him for his years of service to SOREDI. The Succession Plan:

- Tom's official retirement from the SOREDI Board is 3/11/2025
- Chris will finish out his term as the most recent past president, ending June 30, 2026.
- If Steve Vincent is approved as a board director, he will be moved into the Past President role on the Executive Committee
- Kaycee Miller will assume presidency on July 1, 2026, and Breanne Eagles will become Vice President.
