Dr. Todd Bloomquist, Director of School Improvement for the Grants Pass School District, will be sharing a landmark population study called the Adverse Childhood Experiences Study (ACES). This study revealed a relationship between adverse or traumatic experiences in childhood and health and social problems in adulthood. These traumas affect brain development in ways that have direct effects on school and workplace performance, work attendance, productivity and work-related injuries. Dr. Bloomquist will cover key aspects of the ACE study and the impact on communities, but perhaps more importantly, the way that awareness and resiliency have been proven to change the brain, change the way individuals respond to adversity and change negative experiences into positive outcomes for individuals and groups.
